## EDITORIAL

The National Forensic Science Training Institute remains to be resilient in facing the challenges of the new normal. The 2nd half of 2021 has proven that through the passion and dedication of personnel, offering a highly specialized course in crime investigation aided by forensic science is very possible. The NFSTI has passed the 2nd stage audit and is looking forward to its official recognition as an ISO 9001:2015 government agency. The certification will further strengthen the Institute to realize its vision and maintain its affirmation as the premiere training center for a specialized course in Crime Investigation and Detection Course.

As a response to this growing cybercrime rate, the National Forensic Science Training Institute is crafting a Program of Instruction (POI) in helping the law enforcers agencies in solving cyber crimes. Currently, the Institute offers specialization in Investigation and Detection Course (IDC), Narcotics Investigation Course (NIC), and Traffic Investigation Course (TIC). The facilities, pool of faculty, and proven track record is a guarantee that Digital Forensics Investigation Course (DFIC) will be a significant training designed for different government agencies in bridging the gap between justice and crimes committed online. Having said and under PPSC Academic Board Resolution, the NFSTI will offer the Digital Forensic Investigation Course.

Under the "Malasakit Program" which was initiated by PLTCOL RANDY M MALUYO, Ph.D., Director, NFSTI, the Virtual Memorandum of Understanding (MOU) commenced last October 12. 2021. The PCAP was represented by its National President, Dr. Gerry J. Cano. The partnership aims to serve as main channels for information dissemination in terms of the conduct of seminars, research forums, and other related activities that will enhance the skills and learnings of professional criminologists of the Philippines, to exchange the latest trends in the conduct of forensic science and investigation courses in both the academe and applied learning set-up, to share members, administrative officials and subject matter experts for a visit, research, lectures, and discussions, to have a joint organization of conferences, seminars, and workshops on topics of common interest and identify gaps the industry needs.

Headed by Atty. Ramil. Gabao, Ph.D., Chairman of Board of Criminology, the Memorandum of Understanding between NFSTI and BC-PRC has been done. Under MOU, the Professional Regulatory Board of Criminology shall endeavor to propose an exchange program and contributions to the development in the curriculum that will be offered in NFSTI's training program/schedule; conduct a Training-of-Trainers Workshop for NFSTI's identified resource persons and administrators which will thereafter be tasked to cascade their learnings to NFSTI's audiences; and accredit training courses/ programs of the NFSTI in relation to the career progression and specialization of registered criminologists and the NFSTI students, in general. Another key feature of the partnership is that as an accredited institution of the PRC, the PRB CRM shall allow NFSTI to conduct Continuing Professional Development (CPD) course to the personnel of law enforcement as a Srequirement before the license renewal.

Meanwhile, as the world is in the midst of the COVID19 pandemic, the National Forensic Science Training Institute provides support to the personnel through shuttle service, free lunch, alcohol, face mask, and vitamins. The NFSTI has provided isolation rooms and coordinated with medical services to PRO4A and has established coordination with Calamba City Health Office for the vaccination of NFSTI personnel.


The virtual graduation was officially ended after the mass singing of the PPSC Hymn.

## Cyber Crime and Digital Forensics\*

#### **ABSTRACT**

The growing number of smart phone ownership and access to internet has made the Philippines exposed to cyber criminals. The rising popularity of online transaction and social media is an opportunity for cyber criminals to take advantage of victimizing people through identity theft, fraud and malwares - Cyber criminals is seeing light from the dark web. Despite the present of law related to cybercrime, increases in cases were reported. The lack of supervision, awareness of the people on protecting themselves against cybercrimes, weak infrastructure, the technical knowledge of law enforcers and justice system may falling short against on-line criminals.

#### INTRODUCTION

The world is getting connected through the internet and the rise of the internet-of-things makes the community across the globe highly vulnerable in cyber crime (Lillis etc, 2015). The emerging world wide web, smart phones and other computer enabled devices pushed the people to interact online and offline and can freely performed unethical social engagements or simply conducts criminal liabilities (Holt, etc., 2015) As defined, Internet-of-things is the interconnection of all devices using computing devices using the internet infrastructure (Perumal, 2015). The internet-of-things opens a lucrative opportunities in different fields but introduces a new challenge in the area of digital forensic investigations (Zawoad and Hasan, 2015). Criminals are shifting to digital channel as they looked for a shining light in the dark web as they are eyeing for \$2.3 trillion retail industry and is putting conventional retailers at risk of shutting down (Hurlburt, 2017). Another target for cybercrime is the global banking and financial institutions (Camillo, 2017). The transnational crime in the developing world amounting to \$1.6 to \$2.2 trillion and was committed in 11 crimes including the crimes committed online (Kar and Spanjers, 2017). The figure indicates that there is really a need to step-up the cyber security and implement pro-active measures seriously (Abomhara, 2015) and there is no question that this is going global as compared to terrorism (Pakes, 2017).

As the Philippines being part of the emerging digital users is at high risk in cyber attacks which primarily includes fraud, malwares, identity theft and among others. Information on cybercrimes in the country are limited, thus this paper will review on how the government is performing in securing the public against cyber attack.

#### **OBJECTVES OF THE STUDY**

This review discussed how developing countries including the Philippines are getting highly vulnerable in cyber attacks and how the authorities are responding in the identification and resolution of crimes committed online.

#### **METHODOLOGY**

Literature that deals with cyber attacks and digital forensic analysis and investigation were utilized in this study. Sources used were primarily from Google Scholar, ERIC and other open access research journals. The phrases used to search for the information were: cyber crimes, digital forensic, investigation and crimes. Likewise, 'gray' literature was utilized to pay off for the restricted reliable articles on cybercrimes and digital forensic investigation in the Philippines. The paper described the impact of cybercrimes in the economy, people and how different agencies are responding to this emerging type of crimes.

#### **RESULTS AND DISCUSSIONS**

Cyber Security as Human Right

The access in the internet is considered as an emerging human right (Shackelford, 2017) because it is also a way of giving an individual freedom of expressions (Benedek & Kettema, 2014). Internet is a channel that encourages the users to express their thoughts, ideas and sentiments on certain issues specifically in different social media platform and can be anonymous, free from censorship and permission less innovations (DeNardis & Hackl, 2015). Since access to internet is a human right, the government must be committed to ensuring the internet's universality, reliability and sincerity (Tully, 2014). To protect the people, the government is reinforcing its capability to cyber attacks through the improvement of their strategy for digital economy (Teoh & Mahmood, 2017). Private and government are putting investment in cyber security on top of their agenda (Gordon, (2015).

#### Internet Usage of Filipino

On the average, 22% of adult Filipino has smart phones ownership and 40% internet usage between 2013 to 2015 (Poushter, 2016) and grows to 44% and 56% respectively after two years (Poushter, et al., 2018). Based on study, a significant increase of Filipino using internet is 50% and 94% are using mobile devices accessing inside their homes (94%), 22.2% using free WiFi access inside the malls, 11.1% in restaurant and 38.9% access to other public areas (Omorog & Medina, 2018). The number is substantial to put Filipino at risk in cyber attacks such as malware and phishing. As first steps in cyber security, the Philippine government is in need to increase the awareness of the Filipino on crimes committed online.

#### Cybercrime and the Philippines

The Philippines has first tasted internet in 1998 with only 9% internet usage (Labucay, 2014) and has started the Philippines susceptible to hackings. After nearly ten years, internet remains to be a problem and is getting complex (Parcon, 2017). The Republic Act 10175 or the Cybercrime Prevention Act of Philippines has now been in full implementation; still many Filipino became victim of different cybercrimes (Tarun, 2018). In the years 2011 to 2015, there were 55 reports and articles stating that the victim were from nine regions with age ranging from 18 months to 17 years old who were sexually exploited and abused online (Hernandez, et.al, 2018). The rapid growth of online banking and e-payments paved ways to Filipino got engaged to crypto currencies (Geronimo, 2018).

However, the lack of regulatory supervision of crypto currencies has provided cyber criminals to take advantage financial transfer discretely (Biswas, 2018). Trolling, is a new breed of cybercrime appeared in 2016 in which subjective form of expression were published on different social media platform (Cabañes & Cornelio, 2017). Equally, 'keyboard armies' tends to manipulate civil society the manner they think on certain issues and known personality in politics and entertainment arena (Sombatpoonsiri, 2018). Credit cards, online payment and banking have become famous in cyber crime in the Philippines and victims suffer from social and economic sabotage due to identity fraud (Funcion, 2017). To the Philippine government has established a 'cyber-cop' to combat crimes committed in cyber arena through the Philippine National Police Anti-Cyber Crime Group and the Department of Justice (McMahon et al., 2016).

To combat cybercrime, different tools in the crime prevention and detection techniques were being utilized as discussed by Glance

Cybercrime is a multifaceted and forever changing phenomenon. It is found that Cyber criminals who are becoming more classy and stylish are making consumers of both private and public organizations their prey. To prevent attacks additional layers of defense are required. It has been observed that Cyber crime has increased in density and complexity and financial costs ever since organizations have adopted the use of computers in carrying out their business processes. An example of the case studies carried out on cyber crimes is the Parliament attack case. Various prevention techniques and detection techniques like Tripwires, Honey Pots, anomaly detection system, configuration checking tools and operating system commands, various acts that have been imposed against Cyber crime and online safety tips are also discussed.

In the Philippines, a 12 years imprisonment will be imposed to anyone found guilty on online crime (Rama, 2018) and is somehow control the people in committing relevant crimes.

#### Digital Forensic and Investigation

The growing cyber crime reported is alarming (and, the government has started strengthening its personnel for digital forensic training based on volume of the objects of forensic area, importance, unclear network parameters and boundless networks, especially on methodology for conducting the investigation (Perumal, et al., 2015). Digital Forensic Investigation Framework for IoT (DFIF-IoT) that is able to support future IoT investigative capabilities with a degree of certainty (Kebande, 2016). Despite the breakthrough in the areas of Digital Forensic, there is a variety of new digital evidence sources that pose new and challenging problems for the investigator from an identification, acquisition, storage and analysis perspective (Lillis, 2016).

#### CONCLUSIONS

The advancement of technology and communication has speed-up transaction among people across culture and countries.

However, this put the people vulnerability to cybercrimes which includes fraud, identity theft, and malwares. The increase awareness to cyber security is a challenging task for the government. Though there is already an established laws related to cyber crime, there is a gap in the supervision and implementation. The Philippines being one of the fast growing economy in the world is in high risk being attack online. The number of smart phone users and ease of access in the internet make the Filipino more exposed in cyber crimes. The war against cybercrime is one of the top priorities of the Philippine government. The presence of RA 10175, inter-agency coordination and campaign are visible. Generally, the developing countries including the Philippines still need more support and training from the advance government to have a cyber crime free community.

#### RECOMMENDATIONS

It is recommended that the Philippine government shall exert more effort in increasing the awareness of the Filipino people on cyber crimes. As of this writing, this is the only and most feasible way to prevent crimes in the cyber space. Likewise, comprehensive trainings are implemented to the member of the cyber crime group and increase visibility in the international organization to gather support from advance countries. Infrastructure related to cyber security must be in placed as dark web is gaining strength rapidly.

## NFSTI CO-DEVELOPED A TRAINING MANUAL ON HIV SERVICE PROVISION FOR PEOPLE WHO INJECT DRUGS (PWID) AND PEOPLE DEPRIVED OF LIBERTY AND LIVING WITH RIVIDADE

The international community has made tremendous headway in combating the HIV pandemic, but concentrated infections among critical populations continue to be a problem. The persistently high rates of HIV transmission in Eastern Europe, Central Asia, many regions of West, South, and South-East Asia, as well as some portions of Sub-Saharan Africa, are mostly due to HIV infection through hazardous injecting drug use (1). These high rates are the result of a combination of a lack of evidence-based comprehensive HIV services and continuous criminalization and discrimination of PWID (2). Law enforcement (LE) officials Now or affirm to follow the laws of their countries, particularly laws that safeguard public health, fundamental rights, and promote health-related programs and interventions when they are appointed. LE authorities may make a substantial contribution to public health and public safety by supporting programs that work with critical communities to lower their risk of HIV infection and guarantee that all citizens' fundamental right to health is safeguarded.

The development of a resource guide entitled "HIV Service Provision for People Who Inject Drugs (PWID) and People Deprived of Liberty and Living with HIV (PDLHIV) - A Training Manual for Law Enforcement Officers in the Philippines" is a result of TLF Share Collective Inc. and United Nations Office for Drugs and Crime (UNODC) collaboration to adapt UNODC's unpublished global manual entitled "Training Manual for Law Enforcement Officials on HIV Service Provision for People who Inject Drugs", developed in 2014, to the Philippine context.

To ensure contextualizing the manual to the Philippine setting. The TLF Share Collective Inc. and United Nations Office for Drugs and Crime (UNODC) has touched base with the National Forensic Science Training Institute with other key law enforcement agencies such as the Bureau of Jail Management and Penology (BJMP), Department of the Interior, and Local Government (DILG), Philippine National Police (PNP), and learning institutions under the umbrella of the PNP such as Philippine National Police Academy (PNPA), National Police College (NPC), Philippine Public Safety College (PPSC), and the Philippine Drugs Enforcement Agency (PDEA), and PDEA Academy. A series of consultations were conducted to elicit inputs from LE training, academic, and operations perspectives. The enthusiasm and passion of LE agencies and academies enhanced the content of the manual. The development of the manual was guided by the country's national drug and related policies and the timely passage of the Philippine HIV and AIDS Policy Act of 2018 and its Implementing Rules and Regulations (IRR).

Last December 14 to 16, 2021 the output has been pre-tested to get feedback from the end-user at The Manor Hotel, Camp John Hay, Baguio City. The representative of the NFSTI, Mr. Vergel O. Santiago, Chief of Research and Academics Affairs and Administrative Division, and Mr. Hernan Reginio, Public Information Officer and Learning Manager attended the activities.

It is hoped that the use of the manual will assist LE officials and other uniformed officers in building their understanding of HIV prevention, treatment, care, and support services for PWID/PWUD and PDL. More particularly, the manual lays the important role that LE can and will play in collaboration with other stakeholders in enhancing the enabling environment for the Philippines' HIV and AIDS prevention and control program.

The National Forensic Science Training Institute is looking forward that the training manual will be launched and implemented at the soonest time possible.

#### "Nurturing Minds Towards Resilient and Secured Public Safety: Malasakit Webinar Series"

## Theme #1: Empowering Educational Leaders on Character Development, Patriotism, Nationalism and Career Progression

The National Forensic Science Training Institute (NFSTI), the 4th Constitutive Unit of the Philippine Public Safety College envisions itself to be the Center of Excellence in Modern Forensics Investigation in Asia. To realize the vision it will stay committed to providing responsive, scientific, relevant, and continuing investigative education and training to the PNP, BFP, BJMP, allied public safety and security institutions' personnel, and other stakeholders.

The training institutes, SUCs, and the educational system in the country were challenged as face-to-face classes were halted brought about by the global pandemic. Online teaching became the strategy of this institute to cope with its mandate in delivering and maintaining quality services to the students/trainees as information technology and trends also evolve along with this shift of learning scheme. These challenges and realities, make this institute more inspired in meaningful collaboration, partnership, and linkages to SUCs that are far beyond reach. This program is conceptualized as part of the NFSTI's thrust on "Malasakit Community Safety Program" to collaborate with the State Universities and Colleges (SUCs), and Commission on Higher Education (CHED), and Professional Regulation Commission (PRC) to provide an avenue and opportunity for forensics and safety training, which the NFSTI carried out to bridge the gap among law enforcement agencies, allied, public safety and security institutions' personnel and other stakeholders, and the LGU aligned with Community Service-Oriented Policing (CSOP) to synergize the learning objective, best practices, and realities in the ground. One of its goals is to come up with the competency and general overview of what is being taught in the applied training and virtual academic setting in forensics and crime investigation. Furthermore, it aims for subject matter experts (SMEs) from the SUCs (Criminology Schools) to exchange knowledge and expertise and be updated to the current trends and protocols that are being imparted by the public safety training centers in the country, with the





tri-bureaus – the Philippine National Police (PNP), Bureau of Jail Management and Penology (BJMP), Bureau of Fire Protection (BFP) and other allied services.

In this institute, the competencies, skills, and values development are the

highest priorities for the students/trainees as they were joined by the public and private security sectors to be capacitated in favor of the community. Therefore, this program is a way to bridge the gap among law enforcement agencies, allied public safety, security institutions' personnel, and other stakeholders including the local government units.

On September 30 and October 6, 2021, respectively when NFSTI conducted its first webinar which was attended by 1,012 criminology professionals from the academe and various industries across the Philippines. Topics in the webinars were delivered by experts in the field of criminal justice, transnational crime, communist armed conflict, character, and nationalism development. After the invocation, PLTCOL RANDY M. MALUYO, Ph.D. delivered the welcome remarks and provided the participants an overview of the Malasakit Program. Dr. Gerry J. Cano, the President of the Professional Criminologists Association of the Philippines (PCAP) presented a brief description of PCAP. Atty. Ramil G. Gabao, Chairperson, Board for Criminology, Professional Regulation Commission discussed the Career Progression and Specialization for Criminology. Transnational Crime was discussed by PCOL FROILAN P ELOPRE (Ret), the Acting Administrative Division of the Philippine Public Safety College (PPSC) and was followed immediately by the presentation of Nationalism and Patriotism by PMGEN CEDRICK G TRAIN (Ret), the Vice President for Academics of PPSC. A glimpse of Digital Forensic was presented by Mr. Ruck Del Rosario, a subject matter expert in digital forensic.

During the afternoon session, Mr. Jeffrey Celiz presented some information on End Local Communist Armed Conflict. Finally, the PPSC President, PLTGEN RICARDO F DE LEON (Ret), Ph.D. has shared his Character Competency Framework he developed and being implemented to the curriculum of the all mandatory and specialized courses offered by the Philippine Public Safety College. The discussion is very interactive as the chat box was exploded by the questions.

By at large, 86% who attended the webinar is very satisfied with the event. While 89% of the participants expresses that the webinar is very relevant to their current job. The participants are educational leaders from different SUCs and agencies. Moreover, there is a significant number of satisfied participants in the different areas of the webinar. The resource person got the highest satisfaction rating of 72% and was followed by the facilitator and the program flow. The majority of the participants are very satisfied with the invited resource persons. All the speakers used suitable language that can easily understand.

Moving forward, the NFSTI "Malasakit Webinar Series" will be cascaded to over 60,000 criminology students across the Philippines to reach more future law enforcers of the country.

#### And the Legacy Continues...

The KASUROG COPS Program which was initiated by then Region 5 Director, PLTGEN RICARDO F DE LEON has created inspiration to the men and women of the Philippine National Police in the region. Over the past years, it has continued reaching out to the community and creating an impact to elevate the lives of its beneficiaries as well as to build rapport with the different sectors of the country. To continue the legacy, former Regional Training Director 5 and now the Director of National Forensic Science Training Institute (NFSTI), PLTCOL RANDY M MALUYO, Ph.D. added new flavor to the program and was transformed to KASUROG Care. The inspiration has made PLTCOL RANDY M MALUYO, Ph.D. to bring in the principles and ideals of the KASUROG program.

Guided by the objectives of the KASUROG Care, the National Forensic Science Training Institute (NFSTI) has adapted the MALASAKIT Program. Kahit na ang pag-aaral ay tinatawag na "blended learning" at limitado ang "face to face class" ay hindi naging hadlang iyon upang mabuo ang pagkakaibigan ng bawat isa. Malaking bahagi dito ang pagiging mapagsubaybay ng mga course coordinators, kabilang na sila Sir Hernan, mga advisers at mga taong bumubuo ng NFSTI. Sa pamamagitan ng kanilang walang sawang pagsusubaybay, pagbibigay ng mga tinakdang gagawin, pagpapaalala at mga payong lubos na nakakatulong sa lahat kahit man personal na problema. Isa ito sa naging tulay



upang magkaroon ng malawakang ugnayan kung saan nagkaka-buklod-buklod ang lahat hanggang sa makabuo ng isang kaluwagan ng kalooban ng bawat isa, na ang lahat ay makibagay at makisama. Hindi lamang ito tungkol sa pagkakatuto o pagkakaroon ng mga karagdagang kaalaman, tungkol din ito sa pagbuo ng isang matibay at kongkretong kumpiyansa sa sarili na may tiwala sa isa't-isa. Sadya namang marami kaming natutunan sa prestishiyosong institusyong ito na magagamit namin talaga sa totoong buhay ng trabaho. Pwede kang tumawa at magbiruan sa bawat isa, pwede kang umiyak at magbahagi ng mga sentimyento o saloobin, lahat po yan ay pwede dahil sa magandang pagkakalatag ng programa ng mga namamahala ng kurso. Dahil dito ay nabuo agad ang isang pamilya na kinabibilangan naming lahat, Opo, isa kaming pamilya mula sa namumuno dito hanggang sa mga nasa bandang ibaba na mga mag-aaral.
